

# CORE GROUP MEETING November 2 2016 – 9:00 - 10:30 am, NY time MINUTES

Facilitator of the month: Andrew Griffiths, Sightsavers

**Participants**: Marggie Simo (World Vision), Andrew Griffiths (Sightsavers), Busani Sibindi (Save Matabelaland), Naiara Costa (Together 2030 Secretariat).

(1) <u>1st Anniversary of Together 2030</u> – Naiara reviewed the detailed plans and follow up actions and informed that she would be reaching out directly to activity leads for next steps. Naiara will be sending personal emails to members of the Core Group requesting for blog contributions.

Andrew informed that the revamped website is currently under construction and that Sightsavers is already covering the costs associated with those changes. New website will have a better structure and easier navigation as well as a better way for members and partners to register (to become members or for newsletters). All this will be balanced with the need for easy updating, as Naiara will continue to be responsible for keeping the website updated. Work is already in progress and Andrew is checking if the new website can be ready for the 1<sup>st</sup> Anniversary activities.

(2) <u>Face-to-Face meeting</u> - Marggie updated the Group on the plans for a face-to-face meeting to be held in 2017. They are going to share a checklist and a timeline and will propose dates so Members of the Core Group can book their agendas. Recommendation is to have the meeting in March (23-24), in New York, when new Core Group is expected to be in place. Operationalization of the meeting is subjected to the availability of resources.

(3) <u>2017 Workplan</u> – The Group agreed on the need to start drafting the 2017 Workplan as soon as possible and to review it once the expanded Core Group is in place. It was agreed that the next Core Group meeting (Nov 16) should focus on brainstorming for the 2017 Workplan.
