## Jeunes Volontaires pour l'Environnement, Togo, Africa

- JVE implements project addressing local needs that are in line with the SDGs.
- We work with governments and in Togo JVE as part of several government advisory committees
  as a Civil society representative including the energy policy review committee, the national
  climate change committee and the parliamentary environmental advisory committee. In this JVE
  supports the government in the achievement of the national determined contributions.
- Presence in thematic networks in the region also working with regional bodies like ECREEE, the AMCOW among others.
- JVE has been key partner to the UNEP major groups and stakeholders Children and youth as one of the key founders in 2000
- We have been part of the national campaign to prioritize SDGs and towards this JVE is sensitizing communities, working with the government and local communities to localize the implementation of SDGs
- Founding partner of the African Youth Initiative on Climate Change and the work on advocacy on climate change in Africa

## **CANDID CONCEPTS DEVELOPMENT, Bahamas, Latin America and Caribbean**

- My experience with the 2030 Agenda has focused directly on the means of implementation, follow up and review of the new framework specifically aligned with goal #1 the eradication of global poverty which has been marginalized due to multidimensional poverty specifically in the Caribbean.
- Having co-chaired the indicators task force of the Beyond 2015 Campaign I am a stakeholder in the successful implementation of the sustainable development goals. I've been engaged on a national level as well as offering public consultation through capacity building while promoting good governance and peaceful societies as well as conducting research, while engaging in depth dialogues with other partners as it relates to this very ambitious, transformative and universal Agenda.
- The strategic advantage that CCDA brings to the Together 2030 Core Group is influence as well as
  experience. Aside from being very familiar with the 230 indicators for data collection of the
  sustainable development goals. My organization is a member of the TAP Network which
  specifically holds governments, inter-governmental, civil society organizations as well as the UN
  system accountable to its processes for their roles in the success of the global goals.
- I am also an ally with the Borgen Project the most politically influential campaign in the USA working with congressional leaders focused on foreign policy to reduce poverty.
- My organization is positioned on a national level due to my influence with government officials in the Bahamas to impact the implementation phases of the goals. I am also conducting a research project, partnering with the University of the Bahamas that will impact the countries recently drafted national development plan.
- The most important idea I would propose is securing funding for the continued success of this
  initiative by working closer with governments which comes with further developing the mission
  of the initiative and being prepared to engage politicians.
- Another idea would be promote a policy coherence approach, whether the focus is globalization, environment, trade, employment (as we know unemployment will increase by 3.4 million this year-which translates to 201 million jobless further stagnating economic growth and impacting global poverty, which greatly detracts the sustainable development goals.



• CCDA will work to implement indicators at regional, national and subnational levels to complement the global indicators taking into account national circumstances as we see nations begin to progress domestic policies which gravely affect the global goals.

## Sreekanth S Rameshaiah (Sree) - Mahiti

# MAHITI TRUST, India, Asia.

- I bring personal field level technology experience and now a specialist team of 60 technologists and sector specialists focusing on use of technology for furthering SDGs.
- I began my career in 1998 as an Information Technology engineer for a large rural development organisation (SAMUHA) in a drought prone rural area 300 kms north of Bangalore, India. In 1998 using remote sensing data we scientifically designed a watershed program serving a community of 40,000. This was the first implementation of its kind in the region.
- We followed this by implementing a micro-banking tool called Village-Money for women's self help groups having 30,000 members in 1999. Soon we realised the value of using technology to aid social impact initiatives to scale and enhance impact. We started partnering with other nonprofits and developmental agencies, enabling them to use technology in their program design and implementation.
- We spun off Samuha's tech team into Mahiti, an independent social initiative in 2003. Association
  has continued with Samuha over the years. Currently we are helping to monitor and evaluate
  outcomes in agriculture, health and livelihoods through use of mobile and cloud technology.
- Mahiti is now has extensive field experience partnering with government and civil society organisations.
- Health Data collection and Program monitoring:
  - National survey among HRGs for HIV/ AIDS in partnership with Ministry of Health India, PHFI, FHI360 and USAID (Covered 250,000 respondents across India)
  - National Patient Satisfaction Survey for patients using public health services (feedback solicited from 200,000 patients daily in 100 hospitals across 7 Indian states - scaling nationally)
- Education Monitoring scholastic learnings
  - 1.1million children across 27,000 public schools in rural areas of Karnataka, India
  - o 900+ remote schools covering 50,000 children in mountainous area of north-India
- Livelihood Systems support
  - o Digital pedagogical applications for skill development of 20,000+ unemployed rural youth
  - Marketplace commissioned for 100,000 rural micro-entrepreneurs to buy and sell their produce
- We have also partnered with Governments, CSO and development agencies in Bangladesh, Laos, Tajikistan, Brazil, Kenya and Tanzania to take social impact initiatives to scale.
- I along with Mahiti offer a strong southern perspective and experience at Local, National and International levels
- We have taken our perspective to international fora such as:
