HLPF influencing and overall engagement

A. General update on HLPF

- Participation of the stakeholders is quite a challenging- issues on selecting speakers and funding and last minute confirmations.
- Preparatory HLPF meeting on July 10 with MGoS – Arelys and Marggie will attend
- Ministerial Declaration- informal negotiations led by Peru and Australia. There was a call last Friday to discuss developments. There is insisting to keep the declaration small and concise. Still very little wording on MGoS participation
- Co-facilitators hope to finish the final document this week
- Member states will have 15 minutes to presenting- this presentation will be made by high level officials



B. Mapping

- In process to have all put in one document and then the draft will be ready for feedback.
- Short deadline for comment tomorrow- 24 hrs turnaround
- Andrew is working with his design team to have template ready
- 12 case studies showcasing their experience. Unable to get one from Fiji
- Format will have one page of analysis and then the case studies
